Business Items to Consider

4.A Appoint Municipal Court Judge

For this agenda item, the Commission is asked to appoint Attorney Joslyn Kusiak, of Kelly & Kusiak Law Office LLC, Independence, KS, as the Neodesha Municipal Court Judge. Judge Kelly has notified Staff that he will be retiring from his position as our judge.

RECOMMENDED MOTION: I move to appoint Joslyn M. Kusiak as the Neodesha Municipal Court Judge with a monthly salary of \$900.

4.B Approve Storm Siren Purchase

In 2018, the City purchased one storm siren, and the associated software, for emplacement in our community. The plan had originally included the purchase of two additional storm sirens in 2019. During the 2019 budget season (June-August 2018), the Commission decided to purchase and emplace only one storm siren in 2019. For this agenda item, Staff is asking the Commission to approve the purchase of the storm siren. Fire Chief Banzet will have the final updated price quote for the meeting. The approved budget amount, for 2019, is \$22,280

RECOMMENDED MOTION: I move to approve the purchase of one storm siren from Federal Signal, at a cost not to exceed______.

4.C Set Work-Session Date

Staff is requesting that the Commission consider setting a date for a Commission work session, to discuss budget/finance issues. Topics will include the health of the 2018 budget, status of reserve fund balances, automated metering, project costs and payment strategies for water/sewer, gas line, and City Hall/Police Department projects.

This being the time for the continued Public Hearing regarding the Dangerous Structures located at 1401 N. 2nd, the Public Hearing was open and comments were invited. The Public Hearing was then closed.

ORDINANCE NO. 1712

AN ORDINANCE AUTHORIZING AND DIRECTING THE REMOVAL OF CERTAIN UNSAFE AND DANGEROUS STRUCTURES LOCATED ON, LEGAL DESCRIPTION: BLOCK 3, LOTS 13-19, DEER'S SUBDIVISION, CITY OF NEODESHA, WILSON COUNTY, KANSAS, COMMONLY KNOWN AS 1401 N. 2ND, NEODESHA, KANSAS, AUTHORIZING THE FINANCING OF THE COSTS OF SUCH REMOVAL BY THE SALE OF SALVAGE FROM SUCH STRUCTURES, IF ANY, AND/OR FROM THE GENERAL FUND OF THE CITY, AND THE LEVYING OF SPECIAL ASSESSMENTS AGAINST THE LOTS ON WHICH SUCH STRUCTURE IS LOCATED.

Commissioner Moffatt moved to approve Ordinance 1712 directing the removal of the dangerous and unsafe garage structure at 1401 N. 2nd Street. Seconded by Commissioner Johnson. Motion carried.

RESOLUTION NO. 18-23

A RESOLUTION FIXING A TIME AND PLACE AND PROVIDING FOR NOTICE OF A HEARING BEFORE THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS AT WHICH TIME THE OWNER, HIS AGENT, LIENHOLDERS OF RECORD AND OCCUPANTS OF THE STRUCTURE LOCATED AT 306 BELL STREET, LEGAL DESCRIPTION: BLOCK 1, LOTS 15-21, BLISS SUBDIVISION, CITY OF NEODESHA, MAY APPEAR AND SHOW CAUSE WHY SUCH STRUCTURE SHOULD NOT BE CONDEMNED AND ORDERED REPAIRED OR DEMOLISHED AS AN UNSAFE OR DANGEROUS STRUCTURE.

WHEREAS, Ed Truelove, the Enforcement Officer of the City of Neodesha, did on the 19th day of December, 2018, file with the Governing Body of said City a statement in writing that certain unoccupied structures hereinafter described are unsafe and dangerous;

NOW, THEREFORE, BE IT RESOLVED by the Governing body of the City of Neodesha that a hearing will be held on the 13th day of February, 2019, before the Governing Body of the City at 2:00 p.m. in the Commission Room of City Hall, 1407 N. 8th; at which time the owner, his agent, any lien holder of record and any occupant of the structure located at 306 Bell Street may appear and show cause why such structure should not be condemned as an unsafe or dangerous structure and ordered repaired or demolished.

BE IT FURTHER RESOLVED that the City Clerk shall cause this Resolution to be published two consecutive times and shall give notice of the aforesaid hearing in the manner provided by law.

Commissioner Johnson moved to adopt Resolution 18-23 setting a Public Hearing for 306 Bell on February 13, 2019 as presented. Seconded by Commissioner Moffatt. Motion carried.

RESOLUTION NO. 18-24

A RESOLUTION FINDING THAT FINANCIAL STATEMENTS AND REPORTS PREPARED IN CONFORMITY TO GENERALLY ACCEPTED ACCOUNTING PRINCIPLES ARE NOT RELEVANT TO THE REQUIREMENTS OF THE CASH BASIS AND BUDGET LAWS OF THE STATE AND ARE OF NO SIGNIFICANT VALUE TO THE GOVERNING BODY OR MEMBERS OF THE GENERAL PUBLIC OF THE CITY OF NEODESHA.

WHEREAS, The Governing Body of the City of Neodesha, Kansas, did on the 28th day of October, 1986, pass and approve Charter Ordinance No. 4 exempting itself from the provisions of K.S.A. 75-1120a as amended, insofar as said statutes require fixed asset records; and

WHEREAS the City of Neodesha, Kansas, has determined that the financial statements and financial reports for the year ended December 31, 2018 to be prepared in conformity with the requirements of K.S.A. 75-1120a(a) are not relevant to the requirements of the cash basis and budget laws of this state and are of no significant value to the governing body or the members of the general public of the City of Neodesha and

WHEREAS there are no revenue bond ordinances or resolutions or other ordinances or resolutions of the municipality which require financial statements and financial reports to be prepared in conformity with. K.S.A. 75-1120a(a) for the year ended December 31, 2018. (continued on next page)

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF NEODESHA:

<u>SECTION 1</u>. That the Governing Body waives the requirements of K.S.A. 75-1120a(a) as they apply to the City of Neodesha for the year ended December 31, 2018.

SECTION 2. That the Governing Body shall cause the financial statements and financial reports of the City of Neodesha to be prepared on the basis of cash receipts and disbursements as adjusted to show compliance with the cash basis and budget laws of this State.

Commissioner Moffatt moved to adopt Resolution 18-24 regarding the GAAP Waiver as presented. Seconded by Commissioner Johnson. Motion carried.

Administrator Truelove addressed the Commission regarding the fireworks contract for 2019. Discussion was held.
