 - \$30 p/hr. for use of backpack blowers (leaf removal), picking up downed limbs and trash in city parks (routine)

Leaf Removal:

- \$50 p/hr.
 - O Done during leaf removal season to maintain beautification of city properties, as well as prevent accumulation of debris in city ditches and drains.
 - o Necessary for all new grass, seeding and over-seeding in the Fall.

Estimated annual cost for Mowing: \$16,800

Estimated annual cost for Leaf Removal: \$1,500

Estimated annual cost for Maintenance Program (spray, seed, fertilizer): \$3,800

Joey's Lawn Services propose the use of Fescue verse Bermuda for use in Neodesha City Parks. Bermuda requires increased sun exposure for growth, which is not likely to occur with the tree cover in the parks. Fescue does well in both shaded and high sun areas. Some will argue that Fescue requires more maintenance than Bermuda, however this is false. Both have advantages and disadvantages for use. We believe Fescue will provide a more resilient and versatile turf for park goers.
