1. Appropriation (2021) 04

Due to recent staffing issues, we have not been able to prepare certain City bills for payment. The Commission is asked to approve Appropriation (2021) 04 for payment.

2. Approve Purchase of Fire Truck Pump Unit

At a recent residential fire scene, the Fire Department's pump truck was damaged. During scheduled testing of fire trucks, the determination was made by the technician that the pump unit must be replaced. The Commission is asked to approve the purchase and installation of a new pump unit, by Emergency Apparatus Maintenance, Inc., at a cost of \$14,200.

RECOMMENDED MOTION: I move to approve the purchase of a pump unit from Emergency Apparatus Maintenance, Inc., at a cost of \$14,200.
