#### **RESOLUTION 23-16**

## A RESOLUTION FOR THE CITY OF NEODESHA, KANSAS TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;

**WHEREAS**, the Revenue Neutral Rate for the City of Neodesha, Kansas was calculated as 53.072 mills by the Wilson County Clerk; and

**WHEREAS**, the budget proposed by the Governing Body of the City of Neodesha, Kansas will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

**WHEREAS**, the Governing Body held a hearing on August 9, 2023 allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony; and

**WHEREAS**, the Governing Body of the City of Neodesha, Kansas, having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.

#### THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF NEODESHA:

The City of Neodesha, Kansas shall levy a property tax rate exceeding the Revenue Neutral Rate of 69.741 mills. This Resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.

Commissioner Vail-Keller moved to adopt Resolution 23-16 as presented. Seconded by Mayor Johnson. Motion carried.

This being the time and date published in the official newspaper for the 2024 Budget Hearing, the public hearing was opened by Mayor Johnson. Public comments were heard and considered; the hearing was then closed. Discussion held.

#### **ORDINANCE NO. 1787**

AN ORDINANCE RELATING TO THE REZONING AND CHANGING OF THE OFFICIAL ZONING MAP OF THE CITY OF NEODESHA, KANSAS, FROM R-1 SINGLE FAMILY RESIDENTIAL TO PUBLIC-SEMI PUBLIC OF CERTAIN LOTS IN THE CITY OF NEODESHA, WILSON COUNTY, KANSAS AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

#### BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

<u>Section 1.</u> That the following described real estate situated in the City of Neodesha, Wilson County, Kansas, towit:

Tract 1: Lots 17-20, Block 2, S. J. Shutt's Addition, City of Neodesha, Wilson County, Kansas

Tract 2: South 73' Lots 21-24, Block 2, S. J. Shutt's Addition, City of Neodesha, Wilson County, Kansas (continued on next page)

hereinbefore designated in the R-1 Single Family Residential zone, is hereby rezoned to be included in the Public-Semi Public zone, as defined and determined by Ordinance No. 1199 of the City of Neodesha, Kansas.

Section 2. All ordinances or parts of ordinances in conflict herewith are repealed.

<u>Section 3</u>. This Ordinance shall be in force and take effect from and after its adoption and publication once in the official newspaper of the City.

Commissioner Vail-Keller moved to approve Ordinance 1787 regarding the zoning classification for 904 and 912 Grant Street. Seconded by Mayor Johnson. Motion carried.

Administrator Truelove addressed the Commission regarding the approval of an ordinance that incorporates by reference, the 2023 edition of the Standard Traffic Ordinance (STO). The STO is published by the League of Kansas Municipalities, and allows the City to incorporate by reference the various traffic offense codes applicable to most cities in Kansas. Discussion held.

#### **ORDINANCE NO. 1788**

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF NEODESHA, KANSAS, INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES", EDITION OF 2023, WITH CERTAIN OMISSIONS, CHANGES AND ADDITIONS, PROVIDING CERTAIN PENALTIES AND REPEALING ORDINANCE NO. 1771 AND ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

Standard Traffic Ordinance known as the "Standard Traffic Ordinance for Kansas Cities", Edition of 2023, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. One official copy of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1788", with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable business hours. The Police Department, Municipal Judge, and all administrative departments of the City charged with enforcement of the ordinance shall be supplied, at the cost of the City, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

#### Section 2 TRAFFIC INFRACTIONS AND TRAFFIC OFFENSES:

- a) An ordinance traffic infraction is a violation of any section of this ordinance that prescribes or requires the same behavior as that prescribed or required by a statutory revision that is classified as a traffic infraction in K.S.A. 8-2118.
- b) All traffic violations which are included within this ordinance, and which are not ordinance traffic infractions as defined in subsection (a) of this section, shall be considered traffic offenses.

Section 3 PENALTY FOR SCHEDULED FINES. The fine for violation of an ordinance traffic infraction or any other traffic offense for which the municipal judge established a fine in a fine schedule shall not be less than \$10 nor more than \$1,200. A person tried and convicted for violation of an ordinance traffic infraction or other traffic offense for which a fine has been established in a schedule of fines shall pay a fine fixed by the court not to exceed \$1,200.

#### Section 4 MAXIMUM SPEED LIMITS.

Section 33 of Article 7 of the Standard Traffic Ordinance for Kansas Cities, 2023 Edition, is hereby changed to read as follows: Section 33. Maximum Speed Limits

- a) Except when a special hazard exists that requires lower speed for compliance with Section 32, the limits specified in this section or established as hereinafter authorized shall be maximum lawful speeds, and no person shall drive a vehicle at a speed in excess of such maximum limits.
  - 1) Twenty (20) miles per hour in any business district;
  - 2) Twenty-five (25) miles per hour in any residential district;
  - 3) Twenty (20) miles per hour in school zones between the following hours during the school term on days school is in session: 7:30 a.m. to 8:30 a.m.; 11:30 a.m. to 1:00 p.m.; and 3:00 p.m. to 4:00 p.m. The following areas are school zones: (continued on next page)

Eighth Street between Iowa and Bell Streets Granby Street between Fourth and Tenth Streets Fourth Street between Oak and Elm Streets Idaho Street between Sixth and Seward Streets Tank Street between Sixth and Seward Streets Ninth Street between Iowa and Lincoln Streets Church Street between Eighth and Tenth Streets.

- 4) Thirty (30) miles per hour on that portion of U.S. Highway 75 between Third Street and the Eastern City limits.
- 5) Forty-Five (45) miles per hour on that portion of U.S. Highway 75 from the Western City limits to 14<sup>th</sup> Street
- 6) Thirty (30) miles per hour on that portion of U.S. Highway 75 from 14<sup>th</sup> Street to 9th Street.
- 7) Thirty (30) miles per hour on that portion of the West half of Fourth Street between Tank and Fifth Streets.
- b) Unless otherwise directed by a police officer, the driver of any vehicle within the City Limits shall obey the instructions of all signs and other traffic control devices placed within the City Limits by the City of Neodesha. This requirement is subject to the exceptions granted to the driver of an authorized emergency vehicle in this ordinance.

Section 5 ORDINANCES REPEALED. Ordinance No. 1771 and all or parts of ordinances in conflict herewith are hereby repealed.

<u>Section 6</u> EFFECTIVE DATE. This ordinance shall be in full force and effect upon its publication in the official city newspaper.

#### **ORDINANCE NO. 1789**

AN ORDINANCE REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE LIMITS OF THE CITY OF NEODESHA, KANSAS, INCORPORATING BY REFERENCE THE "UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES," EDITION OF 2023, WITH CERTAIN OMISSIONS, CHANGES AND ADDITIONS, PROVIDING CERTAIN PENALTIES AND REPEALING ORDINANCE NO. 1772 AND ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

#### BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

Section I INCORPORATING UNIFORM PUBLIC OFFENSE CODE. There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Neodesha, Kansas that certain code known as the "Uniform Public Offense Code," Edition of 2023, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. One official copy of said Uniform Public Offense Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1789", with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable business hours.

SECTION 10.13 AMENDED. Section 10.13 of Article 10 of the Uniform Public Offense Code, Edition of 2023, is hereby amended to read as follows:

10.13 BARBED WIRE AND ELECTRIC FENCES. It shall be unlawful for any person to construct, set up or maintain any barbed wire or above ground electric fence or enclosure within the City in any Residential Zone or Local Business Zone as shown on the Official City Zoning Map incorporated by Ordinance No. 1199.

Section 3 SECTION 10.29 OMITTED. Section 10.29 of Article 10 of the Uniform Public Offense Code, Edition of 2023, Violation of a Public Health Order, is hereby omitted:

<u>Section 4</u> ORDINANCE REPEALED. Ordinance No. 1772 and all or parts of ordinances in conflict herewith are hereby repealed.

<u>Section 5</u> EFFECTIVE DATE. This ordinance shall be in full force and effect upon its publication in the official city newspaper.

#### **ORDINANCE NO. 1790**

#### AN ORDINANCE ANNEXING LAND TO THE CITY OF NEODESHA, KANSAS.

WHEREAS, the following described land is located in Wilson County, Kansas; and

WHEREAS, the following described land meets one or more of the conditions prescribed by K.S.A. 12-520(a) (1)-(6), as amended; and

WHEREAS, the governing body of the City of Neodesha, Kansas finds it advisable to annex such land.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

<u>Section 1</u>. That the following described land, meeting the conditions for annexation prescribed in K.S.A. 12-520, as amended, is hereby annexed and made a part of the City of Neodesha, Kansas:

#### TRACT VII

Commencing at a point Fifty feet (50') West of the Southwest corner of Section Nineteen (19), Township Thirty (30) South, Range Sixteen (16) East; Thence North Nine Hundred Twenty-Five feet (925'); Thence West Seven Hundred Seventy-Five feet (775'); Thence South Nine Hundred Twenty-Five feet (925'); Thence East Seven Hundred Seventy-Five feet (775') to the point of beginning, except the following described tract:

Beginning at a point 50 feet West and 620 feet North of the Southeast corner of Section 19, Township 30 South, Range 16 East; Thence North 300 feet to the southerly line of Wisconsin Street, City of Neodesha; Thence North 89°00' West, 450 feet along said southerly line of Wisconsin Street; Thence South 300 feet; Thence South 89°00' East, 450 feet to the point of beginning.

#### TRACT VIII

Commencing at the Southwest corner of the Southeast Quarter of Section 19, Township 30 South, Range 16 East; Thence East 110 rods; Thence North 80 rods; Thence West to a point 1311 feet West of the Northeast corner of the South Half of the Southeast Quarter of Section 19; Thence South 445 feet; Thence West 400 feet to the center of Fall River; Thence down the middle of Fall River following the meanderings thereof to the South line of Said Section 19; Thence East on said Section line about 34 rods, 6 links to the point of beginning, less and except the following described tract. Beginning at the center of Fall River 2 rods below the dam formerly used by Sprinkles Mill. Later Adams Mill; Thence South to a point 5 rods South of the water's edge on the South side of the river; Thence East 16 rods; Thence North to the center channel of said river; Thence down the center of said river to the point of beginning. Described in Book 126 at Page 4.

Section 2. That this ordinance shall take effect and be in force from and after its publication in the official city newspaper.

#### **RESOLUTION NO. 23-17**

A RESOLUTION FINDING THAT THE STRUCTURE LOCATED AT 1607 B Street LEGAL DESCRIPTION: Lots Twelve (12) and Thirteen (13), Block Four (4), Deer & Parks Subdivision, City of Neodesha, Wilson County, Kansas IS UNSAFE OR DANGEROUS AND DIRECTING THE STRUCTURE TO BE REPAIRED OR REMOVED AND THE PREMISES MADE SAFE AND SECURE.

**WHEREAS**, the Enforcing Officer of the City of Neodesha, Kansas did on the 3<sup>rd</sup> day of April, 2023 file with the governing body of said City a statement in writing that a certain structure, hereinafter described, was unsafe and dangerous; and

WHEREAS, the governing body did by Resolution dated the 14th day of June, 2023, fix the time and place of a hearing at which the owner, his or her agent, any lienholders of record and any occupant of such structure could appear and show cause why such structure should not be condemned and ordered repaired or demolished, and provided for giving notice thereof as provided by law; and

WHEREAS, such Resolution was published in the official city paper on the 22nd day of June, 2023, and on the 29th day of June, 2023, and a copy of such Resolution was served on all persons entitled thereto in all respects as provided by law; and

**WHEREAS**, on this 9th day of August, 2023, the governing body has heard all evidence submitted by the enforcing officer of the city, the owners, agents, lienholders, and occupants of such structure (having appeared or having failed to appear);

## FECA Base and Demand Charge

## Conclusion

- KMEA recommends the Utility build their electric fund balance to where there is 180 days of cash on hand.
  - 90 days is approximately \$1,300,000
  - 180 days is approximately \$2,600,000
- KMEA recommends doing so with small rate increases that focus on a FECA base with a demand charge for Industrial customers. This rate design is appropriate because of the way the Utility incurs costs.
  - This will increase revenue recovered with base rates while lowering revenue recovered through the FECA charge.
  - This will reduce bill volatility while increasing the amount of fixed revenue the utility recovers.

WHEREAS, the City of Neodesha, Kansas, owns, operates and maintains Crowder Park, located at 1st Street and Ohio Street, to provide residents opportunities to be physically active and participate in community activities; and

WHEREAS, the City of Neodesha, Kansas, desires to apply for funding for a Placemaking project to make improvements at Crowder Park from *Pathways to a Healthy Kansas (Pathways)*, a Blue Cross and Blue Shield of Kansas (BCBSKS) initiative in partnership with Live Long, Stay Strong Wilson County; and

**WHEREAS**, the City of Neodesha hereby affirms its commitment to providing greater access to healthy living options for community members, that its involvement with the *Pathways* initiative helps to establish strong community norms for healthier living, and that it is willing to learn more about making healthy environment and health policy changes to help community members live a longer and better quality of life; and

WHEREAS, the City of Neodesha acknowledges that it plays an integral role in creating opportunities for community members to be physically active and provide opportunities for community members to come together in public spaces; and

WHEREAS, Crowder Park is a key community resource used by families with children, aged citizens, and other residents for outdoor activities, physical activity, and community events; and

WHEREAS, due to budget constraints, the facilities at Crowder Park are outdated and need to be replaced and/or repaired; and

WHEREAS, the *Pathways* initiative is structured in terms of "community pathways" that are designed to help the coalition take a holistic, community-wide approach to improving health outcomes by addressing the social determinants of health, including community-based Placemaking projects; and

WHEREAS, the *Pathways* initiative defines Placemaking as the shaping of a place by creatively applying arts, culture, and social context to jump-start economic development, promote community pride and morale, and encourage people to be physically active; and

**WHEREAS,** *Pathways* requires an emphasis and targeted benefits for "populations of focus" outlined by BCBSKS as part of Placemaking efforts supported by a *Pathways* implementation grant; and

WHEREAS, the residential area surrounding Crowder Park is a low resourced neighborhood, including older and abandoned homes and several vacant property sites; and

WHEREAS, Stay Strong, Live Long Wilson County Coalition surveyed residents living close to Crowder Park to identify and prioritize improvements for Crowder Park; and

WHEREAS, the results of this input show strong support for the installation of playground equipment for children, swings, and a slide in Crowder Park; and

**WHEREAS**, the City of Neodesha is seeking funding through a *Pathways* implementation grant to provide these improved facilities at Crowder Park; and

WHEREAS, the anticipated cost of these improvements is approximately \$62,726.71 (See attached budget); and

**WHEREAS**, the City of Neodesha is seeking a *Pathways* implementation grant in the amount of \$48,850 for the costs of the Park improvements; and

**WHEREAS**, the City of Neodesha will provide any funding needed to pay for costs for the improvements to Crowder Park beyond the \$48,850 *Pathways* implementation grant and also provide in-kind labor, project oversight, and maintenance for the Park improvements; and

WHEREAS, if Stay Strong, Live Long Wilson County Coalition has additional available implementation funds of up to \$1,150 for the City of Neodesha Placemaking initiative in Crowder Park, the City will work with the Coalition to ensure that these funds are used to support the Placemaking effort; and

**WHEREAS,** the Governing Body of the City of Neodesha, Kansas, supports the submission of a *Pathways* implementation grant application by the City Administrator.

## NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

**SECTION 1.** The Governing Body of the City of Neodesha, Kansas, does hereby authorize Ed Truelove, City Administrator, to apply for implementation grant funding from the *Pathways* initiative to fund a Placemaking initiative at Crowder Park on behalf of the citizens of Neodesha, Kansas.

**SECTION 2.** The Governing Body of the City of Neodesha, Kansas hereby establishes a Placemaking Policy in relation to *Pathways* funds and commits to:

- 1. Apply for *Pathways* implementation funds, not to exceed \$48,850 to fund Crowder Park improvements as detailed, above;
- 2. Provide funding needed to pay for costs for the improvements to Crowder Park beyond the \$48,850 *Pathways* implementation grant and provide in-kind labor, project oversight, and maintenance for the Park improvements;

- 4. Develop a written policy that Crowder Park is a commercial tobacco-free place, and install signage to promote the space being commercial tobacco free, including vaping;
- 5. Recognize financial contributions provided by Blue Cross and Blue Shield of Kansas through *Pathways to a Healthy Kansas* initiative and acknowledge this financial contribution in signage, social media, written documentation, or other forms of communication regarding the activities;
- 6. Maintain new or improved local facilities paid for with *Pathways* funds for at least five years after installation;

- 8. Complete an Impact Report one year after grant funding is approved to share your impact, successes, challenges and other lessons learned so that BCBSKS continues to improve its work with and support communities throughout the state. sometimes severely corroded causing pre mature seal failure if these are needed it would add \$ 600 to listed price.

#### **Work Completed**

1.1 Put truck out of service, drained pump, unbolted and removed both drive lines, unhooked and removed pump drain valve, unbolted and removed primer assembly, unhooked remote pump shift, unhooked air lines and electrical for pump shift, removed pump cooler from transmission, unbolted and removed pump transmission. Cleaned pump shaft, unbolted and removed cover for mechanical seal, removed seal from rear of pump. unbolted and removed outboard bearing and housing, unbolted and removed front cover, removed seal from front of pump, cleaned all parts, installed new seal in front of pump, installed new seal plate, torqued bolts to spec, installed bearing housing, installed new bearing, installed new snap rings, and cover plate. Installed new seal in rear of pump, installed new cover plate on rear of pump and torqued bolts to spec. Reinstalled pump transmission, torqued bolts to spec, reinstalled all removed items, filled pump with water and checked for leaks - none at this time. Test ran pump no leaks at this time, put unit back in service.
