Additions	to the A	Agenda

RECOMMENDED MOTION: I move to approve the agenda as presented.

4.A: Resolution: Amend Position Classification and Pay Plan Policy

For this agenda item, the Commission is asked to consider Resolution 24-01 which reflects a 2-percent COLA pay increase for all positions. This was approved by the Commission in the 2024 budget.

RECOMMENDED MOTION: I move to approve Resolution 24-01, amending the Position Classification and Pay Plan.

4.B: Resolution: Amend Personnel Policy Manual

For this agenda item, the Commission is asked to consider Resolution 24-02 which would add Veterans Day to the holiday schedule listed in Section 8 of the Personnel Policy Manual. Due to the significance of this Federal holiday, Staff is recommending this be added to the City's Personnel Policy Manual. Currently policy shows 9 observed holidays. The last holiday that was added to the list was Christmas Eve, Resolution 07-16, on 12/28/2007 and before that Good Friday, Resolution 96-36, on 12/19/1996.

RECOMMENDED MOTION: I move to adopt Resolution 24-02 as presented.

4.C: Appoint Vice-Mayor

Due to the expiring term of Commissioner / Vice-Mayor JD Moffatt, the Commission is being asked to designate the appointment of a Vice-Mayor for conducting Commission Meetings and authorized signing purposes in the absence of the Mayor.

RECOMMENDED MOTION: I move to appoint Commissioner	as Vice-Mayor.

4.D: Approve Purchase of Bucket Truck

Our current bucket truck is a 2010 Dodge 1 ton. Purchasing a new bucket truck had been previously delayed due to reallocating capital outlay funds for the automated metering project for two years, and 2023 capital outlay funds were reallocated to repair the costly damages at the substation.

Staff is requesting the consideration of approving the purchase of a 2023 Chevrolet 1 ton bucket truck. Electric Superintendent Hearn has researched a specific truck offering the following information; the truck is available for purchase immediately because it is a demo unit and is discounted \$25,000. If the purchase is not made at this time, the only other option is to get on a waiting list (3 years for a new unit or 1 year for the next demo unit). Also, during safety inspections of the 2010 Dodge last August, it was highly recommended for us to find a replacement due to new safety requirements that the existing unit does not currently meet. The purchase of a bucket truck was approved as a Capital Outlay item in the 2024 Budget.

RECOMMENDED MOTION: I move to approve the purchase of a bucket truck from Master Tech Truck & Equipment, in an amount not to exceed \$180,000.

4.E: Approve Purchase of Airport Hangar Door Motor & Service

For this agenda item, Staff is requesting the Commission to approve the purchase of an airport hangar door motor with continued service and maintenance on the door once it is up and running. This purchase will be for Hangar 1 at the Neodesha Airport. Due to the age and wear of the existing door that is currently inoperable, this purchase is necessary to continue to use the hangar for leasing purposes. Also of note, Hangar 1 is being leased and paid for by an individual who has not been able to house his plane due to the damaged door.

RECOMMENDED MOTION: I move to approve the purchase of a hangar door motor, service and maintenance from Reddi Overhead Door in an amount not to exceed \$9,132.13.

4.F: Accept Retirement Resignation of Public Works Employee

Justin Gildart, Public Works Department Mechanic, has submitted his resignation retirement request with his last day being January 19, 2024. Justin has worked as a mechanic for the City of Neodesha since November 1, 2012. Well wishes and best of luck to Justin.

RECOMMENDED MOTION: I move to accept the retirement resignation of Justin Gildart effective January 19, 2024.

A RESOLUTION OF THE CITY OF NEODESHA, KANSAS ESTABLISHING AND DEFINING THE CITY LIMITS AND BOUNDARIES OF THE CITY OF NEODESHA, KANSAS; REPEALING RESOLUTION 15-22.

BE IT RESOLVED by the Governing Body of the City of Neodesha, Kansas:

Section 1. That the following parcels, pieces and tracts of land be and they are hereby included and brought within the Corporate Limits of the City of Neodesha, Kansas. That hereafter and until altered and changed in accordance with the law, the City Limits and the entire boundaries of the City of Neodesha, Kansas are hereby defined, ordained and determined to be as follows:

WHEREAS there are no revenue bond ordinances or resolutions or other ordinances or resolutions of the municipality which require financial statements and financial reports to be prepared in conformity with. K.S.A. 75-1120a(a) for the year ended December 31, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF NEODESHA: SECTION 1. That the Governing Body waives the requirements of K.S.A. 75-1120a(a) as they apply to the City of Neodesha for the year ended December 31, 2023.
