Mayor Johnson read a proclamation designating the week of May 12 - 18, 2024 as National Police Week, and to further recognize May 15, 2024 as Peace Officers' Memorial Day. A special thanks was given to Chief Sam Tomlinson and the Neodesha Police Department for their dedication and service to our community.

Mayor Johnson read a proclamation designating May 19-25, 2024 as the  $50^{th}$  Anniversary for Emergency Medical Services Week: Honoring our Past, Forging our Future. A special thanks was given to Chief Keenan Fyfe and the Neodesha Fire/EMS Department for their dedication and service to our community.

AN ORDINANCE AMENDING SECTION 16-36 OF CHAPTER 16 OF THE CITY OF NEODESHA CODE REGARDING FEES FOR UTILITIES PROVIDED BY THE CITY OF NEODESHA, WILSON COUNTY, KANSAS AND REPEALING OLD SECTION 16-36 OF CHAPTER 16 OF THE CITY OF NEODESHA CODE.

#### BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

**Section One**: Section 16-36 of Chapter 16 of the City of Neodesha Code shall be amended to read as follows: Sec. 16-36. - Utilities.

- a) Service connection fees:
  - 1. Electricity: \$50.00.
  - 2. Gas: \$50.00.
  - Water: \$50.00.
- b) Transfer fee: \$25.00.
- c) Service fees for non-payment: \$50.00
- d) Returned check NSF fee: \$30.00.
- e) Natural gas:
  - 1. Residential service, monthly rates:
    - a. Meter service charge: \$14.00 per month per meter.
    - b. Commodity charge: \$0.816 per Ccf, plus the cost of gas adjustment.
  - Commercial service, monthly rates:
    - a. Meter service charge: \$16.00 per month per meter.
    - b. Commodity charge: \$0.816 per Ccf, plus the cost of gas adjustment.
  - 3. Industrial service, monthly rates:
    - a. Meter service charge: \$18.00 per month per meter.
    - b. Commodity charge: \$0.816 per Ccf, plus the cost of gas adjustment.
  - 4. Large volume service. Must remain on this rate for the 12-month calendar year.
    - a. Customer charge: \$55.00 per month (includes multiple locations/meters).
    - b. Meter service charge: \$18.00 per month per meter.

      - (1) The first 500 Ccf (0—500) at \$0.795 per Ccf.
      - (2) The next 1500 Ccf (501—2000) at \$0.774 per Ccf.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

**Section One:** Section 16-34 of Chapter 16 of the City of Neodesha Code shall be amended to read as follows: Sec. 16-34. - Traffic and Vehicles.

- Special Purpose Vehicle Permit fees:
- o \$150.00 per calendar year.
- o Permits can be purchased through-out the year and prorated for the time of purchase down to a minimum of \$50.00 (\$12.50 per month.)
- \$50.00 for replacement of lost permit.

Section Two: Old Section 16-34 of Chapter 16 of the Code of the City of Neodesha is hereby repealed.

Section Three: EFFECTIVE DATE. This ordinance shall be in full force and effect upon adoption.

#### **RESOLUTION 24-09**

A RESOLUTION AMENDING THE POSITION CLASSIFICATION AND PAY PLAN FOR THE CITY OF NEODESHA, KANSAS, AS ADOPTED BY THE NEODESHA CITY COMMISSION BY RESOLUTION 18-14.

WHEREAS, K.S.A. 12-101 provides that a city may exercise the powers of home rule in determination of local affairs, and the City of Neodesha is a City of the Second Class as defined by Kansas Statute; and

WHEREAS, the management of the City of Neodesha regarding personnel rules, employee classification plans, compensation and related administrative procedures and policies are a permissible exercise of home rule powers, pursuant to K.S.A. 12-101a; and
