The Board of Commissioners met in regular session at 4:00 p.m., on Wednesday, September 10, 2025, in the Commission Room at City Hall with Mayor Johnson presiding and Commissioners Banzet and Truelove present. The meeting was recorded via Zoom platform.

Mayor Johnson took a moment to congratulate and recognize Utility Billing Supervisor Anita Buchanan on her upcoming retirement after more than 35 years of dedicated service to the City of Neodesha. Anita's last day will be September 19, 2025. The Governing Body and all City employees extend their deepest gratitude for her many years of commitment and wish her much joy, health, and happiness in this new chapter of life.

City Administrator comments were heard.

Community Development Director reports were heard.

Financial reports were distributed.

Public Comments were invited and heard.

Commissioner Truelove moved to approve the consent agenda as presented consisting of minutes from the August 25, 2025 Special Call Meeting; minutes from the August 27, 2025; and Appropriation (2025) 16. Seconded by Commissioner Banzet. Motion carried.

Administrator Jones addressed the Commission regarding a contract agreement with Western Consultants dba Governmental Assistance Services for the 2nd phase of the Granby Street Project Grant process. Discussion held.

Commissioner Truelove moved to approve the contract with Western Consultants dba Governmental Assistance Services in an amount not to exceed \$13,500. Seconded by Commissioner Banzet. Motion carried.

Administrator Jones addressed the Commission regarding a resignation request from Public Works Department employee Chris Cook. Discussion held.

Commissioner Banzet moved to accept the resignation of Chris Cook effective September 13, 2025. Seconded by Commissioner Truelove. Motion carried. Administrator Jones and the Governing Body extended sincere thanks to Chris for his time with the City. His skills, experience and dedication have been instrumental in helping complete several major projects more efficiently and cost-effectively. Well wishes are extended for his future endeavor.

Fire Prevention Week 2025

WHEREAS, the City of Neodesha KS is committed to ensuring the safety and security of all those living in and visiting our City; and

WHEREAS, fire remains a serious public safety concern both locally and nationally, and the presence of lithium-ion batteries in many household devices introduces unique fire risks; and

WHEREAS, most of the electronics used in homes daily — including smartphones, tablets, laptops, power tools, e-bikes, e-scooters, and toys — are powered by lithium-ion batteries, which if misused, damaged, or improperly charged, can overheat, start a fire, or explode; and

WHEREAS, the National Fire Protection Association® (NFPA®) reports an increase in batteryrelated fires, underscoring the need for public education on the safe use of lithium-ion batteries; and

WHEREAS, residents should follow three key calls to action: buy only listed products, charge batteries safely, and recycle them responsibly to prevent battery-related fires; and

WHEREAS, lithium-ion batteries store a large amount of energy in a small space, and improper use such as overcharging, using off-brand chargers without safety certification, or exposing batteries to damage can result in fire or explosion; and

WHEREAS, the proper disposal and recycling of lithium-ion batteries help prevent environmental hazards and reduce fire risks in the home and community; and

WHEREAS, Neodesha's first responders are dedicated to reducing the occurrence of home fires and home fire injuries through prevention and protection education; and

WHEREAS, the 2025 Fire Prevention Week™ theme, "Charge into Fire Safety™: Lithium-Ion Batteries in Your Home," serves to remind us of the importance of using, charging, and recycling lithium-ion batteries safely to reduce the risk of fires in homes and communities.

THEREFORE I, Devin Johnson, Mayor of the City of Neodesha, do hereby proclaim October 5 – 11, 2025, as Fire Prevention Week throughout this City.
