Business Items to Consider

4.A: Ordinance: ECA Calculations Procedure

This ordinance includes a minor adjustment that reduces the monthly ECA charged to our customers. Our current base rate is \$0.045, and the ordinance proposes increasing it to \$0.055. The City will absorb the additional one cent needed to raise the base rate to this new level.

RECOMMENDED MOTION: I move to approve Ordinance 1827 as presented.

4.B: 2026 BCBS/KMIT Health Insurance Renewal

It's that time of year again—our health insurance renewal has been finalized. This year, we are anticipating a 9.9% increase in our coverage costs. While this is still an increase, it is lower than the average rate hike experienced by BCBS members who are not part of KMIT which is around 15%.

RECOMMENDED MOTION: I move to approve the 2026 BCBS/KMIT insurance renewal as presented.

4.C: Approve Interlocal Agreement: Labette Health for EMS Service

This business item was tabled at the 11/12 meeting and later addressed at the special meeting on 11/19. We are now waiting on the attorney's final revisions to the interlocal agreement and expect to have it ready for final approval soon.

RECOMMENDED MOTION: No motion needed.

4.D: Approve 3rd Amendment to amended Grant Agreement: KHRC

The Third Amendment to the Amended Grant Agreement between the City of Neodesha and Kansas Housing Resources Corporation updates the terms of the Moderate Income Housing (MIH) project. The amendment allows the City to rent the two duplexes and three single-family homes built with MIH funds to eligible tenants, following existing program requirements. It also updates the approved construction locations for these homes and sets a completion deadline of June 30, 2026. All other terms of the original agreement and prior amendments remain in full effect, with no changes beyond those stated in this amendment.

RECOMMENDED MOTION: I move to approve the third amendment to the KHRC grant agreement as presented.

4.E: Consider Bid for Surface Prep & Painting of City Pool

We have received the bid for painting the pool, and the contractor has requested to place us on their schedule for early spring. To ensure we are ready to move forward at that time, we decided it would be best to get the bid approved now so everything is in order before we secure our spot on their schedule.

RECOMMENDED MOTION: I move to approve the bid from Ashton Kate Sandblasting & Painting in the amount not to exceed \$43,000 dollars.

4.F: Consider Extended Lunch Break & Closure of City Hall for Employee Christmas Party

We are requesting to close City Hall from 11:00 a.m. to 2:00 p.m. on December 3rd for the employee Christmas party, and to allow all other departments an extended lunch break so everyone can attend and enjoy the event.

RESOLUTION NO. 25-23

A RESOLUTION FINDING THAT THE STRUCTURE LOCATED AT 1011 Carolina, LEGAL DESCRIPTION: Lots Six (6), Seven (7), Eight (8), and Nine (9), Block Three (3), S.J. Shutt's Addition to the City of Neodesha, IS UNSAFE OR DANGEROUS AND DIRECTING THE STRUCTURE TO BE REPAIRED OR REMOVED AND THE PREMISES MADE SAFE AND SECURE.

WHEREAS, the Enforcing Officer of the City of Neodesha, Kansas did on the 10th day of July, 2025, file with the governing body of said City a statement in writing that a certain structure, hereinafter described, was unsafe and dangerous; and

WHEREAS, the governing body did by Resolution dated the 8th day of October, 2025, fix the time and place of a hearing at which the owner, his or her agent, any lienholders of record and any occupant of such structure could appear and show cause why such structure should not be condemned and ordered repaired or demolished, and provided for giving notice thereof as provided by law; and

WHEREAS, such Resolution was published in the official city paper on the 16th day of October, 2025, and on the 23rd day of October, 2025, and a copy of such Resolution was served on all persons entitled thereto in all respects as provided by law; and

WHEREAS, on this 12th day of November, 2025, the governing body has heard all evidence submitted by the enforcing officer of the city, the owners, agents, lienholders, and occupants of such structure (having appeared or having failed to appear);

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF NEODESHA,

THAT said governing body hereby finds that the structure is unsafe and dangerous and hereby directs such structure LOCATED AT 1011 Carolina, Lots Six (6), Seven (7), Eight (8), and Nine (9), Block Three (3), S.J. Shutt's Addition to the City of Neodesha, to be repaired or removed and the premises made safe and secure. The owner of such structure is hereby given 60 days from the date of publication of this Resolution within which to commence the repair or removal of such structure within the time stated or fails to diligently prosecute the same until the work is completed, said governing body will cause the structure to be repaired or razed and removed and the costs of such repair, razing and removing, less salvage if any, to be assessed as a special assessment against the lot or parcel of land upon which the structure is located as provided by law.

BE IT FURTHER RESOLVED, that the City Clerk shall cause this Resolution to be published once in the official city paper and a copy mailed to the owners, agents, lienholders and occupants as provided by law.

Commissioner Banzet moved to approve Resolution 25-23 as presented, allowing the property owner 60 days to abate the property located at 1011 Carolina Street, as directed. Seconded by Commissioner Truelove. Motion carried.

Administrator Jones addressed the Commission regarding an Ordinance for a pole attachment agreement for Gateway Fiber LLC, formerly known as Kwikom Fiber. This agreement finalizes their ongoing operations in Neodesha. Discussion held.

ORDINANCE NO. 1824

AN ORDINANCE OF THE CITY OF NEODESHA, KANSAS AUTHORIZING THE EXECUTION OF A POLE ATTACHMENT AGREEMENT AND AN ADDENDUM TO THAT POLE ATTACHMENT AGREEMENT WITH JMZ CORPORATION, A KANSAS CORPORATION THAT FORMERLY DID BUSINESS AS KWIKOM COMMUNICATIONS BUT IS NOW DOING BUSINESS AS GATEWAY FIBER FOR THE ATTACHMENT OF COMMUNICATION AND BROADBAND FACILITIES ON CITY OWNED UTILITY POLES.

WHEREAS, the City of Neodesha, Kansas (the "City") owns and operates a municipal electric utility system, which includes various utility poles located within the City's corporate limits; and

WHEREAS, the City has determined that granting access for telecommunications and broadband providers to attachment equipment to City-owned poles is in the public interest, as it promotes competition and the deployment of advanced communication services; and

WHEREAS, JMZ Corporation, a Kansas corporation that formerly did business as KwiKom Communications and is now doing business as Gateway Fiber (the "Provider") has requested to attach its communications and broadband facilities to the City's utility poles; and

WHEREAS, the City and Provider have negotiated a Pole Attachment Agreement (the "Agreement") outlining the terms, conditions, and fees for the Provider's use of the City's utility poles; and

WHEREAS, Provider formerly did business in Kansas under the name KwiKom Communications and has notified the City that it has changed its doing business as name (its "d/b/a") to Gateway Fiber; and

WHEREAS, Provider and the City wish to formally amend the Agreement via an Addendum to the Agreement (the "Addendum") to reflect this change in the Provider's d/b/a name; and

WHEREAS, except as expressly modified by the Addendum, all other terms and conditions of the Agreement shall remain unchanged; and

WHEREAS, the Agreement provides for the review, approval, or denial of attachment requests based on sufficient capacity, safety, and reliability requirements, and generally applicable engineering standards, in compliance with all applicable laws; and

WHEREAS, the City Commission has reviewed the proposed Agreement and Addendum and finds they are in the best interests of the City and its citizens.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NEODESHA, KANSAS:

Section 1. Authorization for Agreement and Addendum. The City Commission hereby authorizes and approves the Pole Attachment Agreement and the Addendum to the Pole Attachment Agreement between the City of Neodesha, Kansas and JMZ Corporation, that formerly did business as KwiKom Communications, but which is now doing business as Gateway Fiber, in substantially the form attached hereto as Exhibit A-Pole Attachment Agreement and Exhibit B-Addendum to Pole Attachment Agreement.

Section 2. Execution. The Mayor is hereby authorized and directed to execute the Agreement and the Addendum, and the City Clerk is directed to attest thereto.

Section 3. Other Actions. The Mayor, City Administrator, and other appropriate City staff are authorized to take all actions necessary to implement the terms of the Agreement, the Addendum, and this Ordinance.

Section 4. Effective Date. This Ordinance shall take effect and be in force from and after its passage, approval, and publication in the official city newspaper.

AN ORDINANCE AUTHORIZING AND DIRECTING THE REMOVAL OF CERTAIN UNSAFE AND DANGEROUS STRUCTURES LOCATED AT 923 ILLINOIS STREET ON LEGAL DESCRIPTION: Lots 11 and 12, Block 14, Ford's Addition to the City of Neodesha, Wilson County, Kansas, AUTHORIZING THE FINANCING OF THE COSTS OF SUCH REMOVAL BY THE SALE OF SALVAGE FROM SUCH STRUCTURES, IF ANY, AND/OR FROM THE GENERAL FUND OF THE CITY, AND THE LEVYING OF SPECIAL ASSESSMENTS AGAINST THE LOTS ON WHICH SUCH STRUCTURE IS LOCATED.

WHEREAS, the governing body did after proper notice and hearing as provided by law make findings by Resolution 25-20 dated October 14, 2025, that the structure hereinafter described as unsafe and dangerous and did direct the owner of such structure to repair or remove the same and make the premises safe and secure, together with the statement that if the owner failed to commence the repair or removal within the time fixed by such resolution or failed to diligently prosecute the same until the work was completed, the city would cause the structure to be razed and removed, and

WHEREAS, such resolution was published in the official city newspaper and copies of such resolution were mailed to each owner, agent, lienholder of record and occupants of such structures and were otherwise served as required by law, and

WHEREAS, the owner has wholly failed to commence the repair or removal of such structures; now therefore

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

Section 1: The enforcing officer is hereby authorized and directed to cause the dwelling located at 923 ILLINOIS STREET, on legal description: Lots 11 and 12, Block 14, Ford's Addition to the City of Neodesha, Wilson County, Kansas, to be razed and removed and the premises be made safe and secure and for this purpose is authorized to invite bids, negotiate a contract, or cause the work to be done by city employees.

Section 2: The enforcing officer shall keep an account of the cost of the work and may sell the salvage from such structures and shall keep an account of the receipts therefrom as provided by law.

Section 3: All costs incurred by the city in the razing and removal of such structures and the making of the premises safe and secure shall be paid from moneys received from the sale of salvage therefrom and all moneys in excess of that necessary to pay such costs shall, after the payment of all costs, be paid to the owner of the premises upon which said structures were located: PROVIDED, that if there is no salvageable material or if moneys received from the sale of salvage is insufficient to pay the cost of such work, such costs or any portion thereof in excess of the amount received from the sale of salvage shall be assessed as a special assessment against the lots on which the structure was located and may be financed until the assessment is paid out of the general fund of the city.

Section 4: EFFECTIVE DATE. This ordinance shall be in full force and effect upon its publication in the official city newspaper.

ORDINANCE NO. 1827

AN ORDINANCE AMENDING CHAPTER 36, ARTICLE IV, DIVISION 2, SECTION 36-170 OF THE CODE OF THE CITY OF NEODESHA RELATING TO THE ELECTRIC UTILITY POWER ADJUSTMENT AND REPEALING PRIOR SECTION 36-170 OF ARTICLE IV, DIVISION 2, CHAPTER 36 AND ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEODESHA, KANSAS:

Section One: Section 36-170 of Article IV of Division 2, Chapter 34 of the City of Neodesha Code shall be amended to read as follows:

Sec. 36-170. – Power Cost Adjustment Clause

The charge per kWh may be adjusted each month under the following formula: ((A / B) * (1 + C)) - \$0.055

Where:

- A = The total costs associated with delivering power to the City.
- B = Total kWh delivered for the system for the month.
- C = The percentage of kWh delivered to kWh sold under sections 36-167 through 36-169.

\$0.055 = The base cost per kWh upon which the current electric rates are based.

<u>Section Two</u>: The prior Section 36-170 of Article IV, Division 2, of Chapter 36 of the City of Neodesha Code and all ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section Three: EFFECTIVE DATE. This ordinance shall be in full force and effect upon its publication in the official city newspaper.

Passed by the Governing Body of the City of Neodesha, Kansas and signed by the Mayor this 26th day of November, 2025.

THIRD AMENDMENT TO THE AMENDED GRANT AGREEMENT

This Third Amendment ("Third Amendment") to the Amended Grant Agreement between the City of Neodesha, Kansas ("Grantee"), 1407 North 8th Street, Neodesha, Kansas 66757, and Kansas Housing Resources Corporation ("KHRC"), 200 SW 6th Ave., Topeka, KS 66603, is effective [Date], 2025 ("Effective Date").

WHEREAS, KHRC administers the Moderate Income Housing ("MIH") program, which through the State Housing Trust Fund ("SHTF"), provides loans or grants to cities or counties for infrastructure or housing development in rural areas of the State of Kansas;

WHEREAS, Grantee and KHRC entered into an Amended Grant Agreement dated November 15, 2022 (the "Grant Agreement") under which KHRC agreed to allocate MIH funds to Grantee, and Grantee agreed to use those funds to complete certain Eligible Activities as defined and detailed in the Agreement, and which was amended by the parties pursuant to First Amendment to the Amended Grant Agreement dated January 8, 2025 ("First Amendment") and a Second Amendment to the Amended Grant Agreement dated May 29, 2025 ("Second Amendment") (the Grant Agreement, First Amendment, and Second Amendment are collectively referred to hereinafter as the "Agreement");

WHEREAS, Grantee requested to modify the Eligible Activities set out in the Agreement to provide for changes as set forth herein; and

WHEREAS, the parties desire to modify the Agreement to provide for the abovereferenced amendment and otherwise to ratify and confirm the Agreement in its entirety.

NOW THEREFORE, in consideration of the mutual covenants set forth herein and for other good and valuable consideration, the parties agree as follows:

- Paragraphs 2 a. and 2.b. of the Agreement shall be and are hereby amended to allow Grantee the option of renting the two (2) duplexes and three (3) single family homes constructed as part of the Eligible Activities to eligible MIH qualified tenants in accordance with the terms and conditions of the Agreement, including the requirements set out in Paragraph 8 of the Agreement.
- Furthermore, Paragraphs 2.a. and 2.c. of the Agreement shall be and is hereby amended to allow Grantee to construct the duplexes and single family homes referenced above in Paragraph 1 located at 902 N 9th St., 904 N 9th St., 820 Carolina St. and 822 Carolina St., Neodesha, KS 66757. The construction of the development under the Agreement shall be completed no later than June 30, 2026.

- 3. All other terms and conditions of the Agreement are hereby ratified and affirmed. The parties reaffirm all certifications and representations made in the Agreement and understand that there has not been any waiver or modification of any of the terms or conditions of the Agreement except as expressly stated herein.
- 4. This Third Amendment embodies the entire agreement and understanding of the parties hereto with respect to the subject matter contained herein. No alteration, modification, or change to this Third Amendment shall be valid unless executed in writing by the parties hereto.

IN WITNESS WHEREOF, the parties hereto have executed this Third Amendment to the Agreement between Grantee and KHRC as of the date stated above.

All surfaces shall be scrubbed with SC-200 heavy-duty degreaser, then washed to remove laitance, mold, fungi, organic pathogens, and other airborne contaminants. This method is performed so the blasting doesn't drive the oils, fungi, and other pathogens or contaminants into the surface that could cause paint failure.

All surfaces shall be brush blasted to remove all loose and deteriorating coatings. After the blasting operation is completed, all cracks shall be patched with Tnemec's series 215 epoxy patch. This method will provide the proper profile and anchor pattern for the application of new coatings.

All debris paint chips, dirt, sand media, etc. From blasting shall be cleaned up and disposed of by this contractor. Prior to sandblasting, the contractor shall perform all necessary covering and protecting of adjacent and non-scheduled surfaces. After preparation is completed, all blasted surfaces shall be acid-washed and scrubbed once again. Ashton Kate Construction follows all OSHA safety regulations in scaffolding and
